

## Official Rules

### **NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of MingsBings Inc. ("Sponsor") as final in all matters relating to this Sweepstakes.

**Eligibility:** This Sweepstakes is open to legal U.S. residents through 5:00pm (PST) December 31, 2024.
